



BURNABLE

Cardboard, paper, plastic (not reinforced), styrofoam, wood and laminate.



TEXTILES

Mixed textiles (not allowed to throw away upholstered furniture as sofas and similar).



PLASTIC

Soft, hard, and mixed plastics from packaging and wrapping (100% clean from other contaminants. Not reinforced plastic).



WOOD

Wood with or without treatment, painted, oiled or wood from demolition. (Impregnated wood is not allowed and is a separate fraction).



REINFORCED PLASTIC

All types of reinforced plastic. (100% clean from other contaminants).



IMPREGNATED WOOD

Treated and impregnated wood. Must be separated from other wood waste.



COMPOSITE ASSEMBLIES

Materials that can not be separated. E.g. gypsum/plaster with tiles, Paroc panels, Complete wall blocks with gypsum/wood/metal/insulation.



PLASTER

Clean installation waste (clean and dry), as well as mixed plaster from demolition (100% clean from other contaminants).



CORRUGATED PAPER

Clean corrugated paper from wrapping & packaging (100% clean from other contaminants).



INSULATION

All kinds of insulation material, like mineral wool, stone wool, perlite etc.



GRINDING DUST

Grinding dust from, e.g. concrete or other plastered surfaces. Packed in transparent plastic bags and then placed in either construction bags or container.

Must not contain epoxy.



METAL

For example rebar, sinks, plates, metal strip, roofing, ventilation pipes, steel pipes, copper pipes, bathtubs, metal studs, steel beams, lighting fittings without electronics. (100% clean from other contaminants).



REINFORCED CONCRETE

Maximum size 30x30x30 cm (all greater sizes, ask for offer).



FILL MATERIAL

- 1. Clean fill soil (<KM):** Sand, gravel, stones, crushed concrete, lightweight concrete (only clean no contaminants & separated in fractions, 100% clean from other contaminants).
- 2. Mixed fill soil (<MKM):** Concrete, tiles, ceramics, clean or mixed with each other as well as "clean fill soil" mixed with each other. No greater than 5% volume weight soil products (100% clean from other contaminants).
- 3. Soil (clean):** Excavated soil masses. Content of organic plant material and clay maximum of 5% volume weight.
- 4. Soil:** Excavated soil masses. Content of organic plant material and clay maximum of 25% volume weight.
- 5. Asphalt:** Chemical analysis is required.*



HAZARDOUS WASTE
